



## Royal New Zealand Ballet & Viking Competition Terms and Conditions

### 1. Promoter

The promoter of this competition is the Royal New Zealand Ballet (RNZB) ("Promoter"). The prize is supplied by Viking ("Prize Supplier").

### 2. Eligibility

Entry is open to residents of New Zealand aged 18 years and over. Employees of the Promoter, the Prize Supplier, and their immediate families are not eligible to enter.
